

THE ULTIMATE NET-A-PORTER PARTY WARDROBE

1. The Ultimate Net-A-Porter Party Wardrobe is available to buy by three (3) customers ("**Customer(s)**") from NET-A-PORTER'S website (the "**Website**") and provides each Customer with access to the NET-A-PORTER Personal Shopping Team in order to assist each Customer in building a new wardrobe of items, excluding beauty, fine jewellery and watch items (the "**Gift**"), worth up to the Gift's total retail price, as listed on the Website from time to time (inclusive of VAT (where applicable) or plus any other sales tax and/or customs duties where due) ("**Limit**").
2. It is at each Customer's discretion as to how they spend this Limit; however, once the Limit is reached, even if this is prior to the one (1) year redemption period ending (as referred to in paragraph 10 below), then no further items will be provided as part of the Gift. At the end of the year, if any of the Limit has not been used, then this will be issued to the Customer as store credit.
3. The Gift will only apply to full price items. The Gift does not apply to items that are on sale and the Gift cannot be combined with any promotion, discount offer, code, certificate, or coupon.
4. Once having purchased the Gift, each Customer will be contacted by the NET-A-PORTER Personal Shopping Team who will work with the Customer to complete purchases up to the Limit of the Gift.
5. The Customer may request one (1) meeting in person with a NET-A-PORTER Personal Shopper, such Personal Shopper to be allocated at NET-A-PORTER's discretion ("**Appointment**") in order to assist the Customer with using the Gift. Travel to and from the Appointment shall be excluded and other exclusions may apply but will be communicated to the Customer as and when they enquire about making an Appointment.
6. Items provided as part of the Gift can be exchanged in line with NET-A-PORTER'S returns policy. Otherwise, the Gift is non-transferable, non-exchangeable and no cash alternative is offered.
7. The Gift is personal to each Customer and is purchased for private (not commercial) use.
8. The Customers may be required to participate in publicity in connection with the Gift.
9. Images of the Gift in the product description are for illustration purposes only.
10. The Gift must be redeemed within one (1) year from the date of purchase.
11. Any delivery costs associated with the Gift will be complimentary but please note that exclusions and shipping restrictions may apply.
12. NET-A-PORTER reserves the right to cancel the Gift if it feels that a Customer has violated any of these terms.
13. NET-A-PORTER reserves the right to cancel or amend these terms at any time and without prior notice. These terms do not affect the Customers' statutory rights.
